
One Time Donation. You may make a one-time donation in any amount to this fund. A \$2,000 donation would roughly equal a one semester scholarship, a \$4,000 donation would equal a one year scholarship.

A Gift of Legacy. A legacy gift to The Low Income and Hardship Scholarship Fund ensures that needy students in Lancaster will receive support for years to come. Legacy gifts include naming The Low Income and Hardship scholarship Fund as a beneficiary in your will or making a donation through an endowment, annuity, and other estate planning tools. Tribute/Memorial Donations. Honor those that mean the most to you with a tribute or memorial contribution. Tribute contributions are often made to commemorate birthdays, weddings, and anniversaries, among other special events. Memorial contributions are made to honor those who have passed on.

Monthly Giving Program. You can use The Low Income and Hardship Scholarship Fund's automatic payment plan to provide even more scholarship assistance for needy students. A monthly commitment provides a regular source of income that allows us to more effectively plan and budget our programs, while your automatic deductions help reduce administrative costs. The combination of reduced expenses and increased income means more students will receive scholarship support, while making monthly pledge payments easy for you.

A. Monthly Giving Via Credit Card. If you are interested in having the monthly giving program charged to your credit card, please arrange this with our office. On the 15th of each month the specified amount will be charge to your credit card. Your bank statement or credit card bill will show your monthly gift and will serve as a receipt for tax purposes. In addition, you will receive an annual acknowledgment including the total amount of gifts.



B.Monthly Giving Via Checking Account. If you prefer to organize a monthly giving program through your bank account, please schedule a month payment with your bank from your checking account to the CCA Low Income and Hardship Fund, 1850 Kershaw Camden Hwy., Lancaster, SC 29720. Your gift will be reliably and safely deposited to the CCA Low Income and Hardship Fund each month. Your bank statement will reflect your monthly gift and will serve as a receipt for tax purposes. In addition, you will receive an annual acknowledgment from the CCA Needy Student Fund stating the total amount of your gifts.

Matching Gifts. Your donation may be worth even more. At no additional cost to you, your employer may match or even double your contribution to the CCA Needy Student Fund. Many companies even match donations by retirees and spouses of employees. Ask your employer how you can multiply your gift.
